## 2023-24 Middle Georgia Ladies Championship Tournament Rules

1. ELIGIBILITY: Competition is limited to members of Middle Georgia USBC Assn, Inc., in a certified league at any center serviced by that association and must be in good standing. Must be at least two teams for this tournament to run.
2. SCHEDULING, LINE UP and SUBSTITUTES: Bowlers will bowl in the order that they are listed on the entry form. Check in will be 30 mins before the scheduled shift. Substitutes will check in at that time and bowl in the position of the absent bowlers. Bowlers can bowl Singles - Doubles - Team or any combination. Bowlers must bowl all three events to be eligible for All Events.
3. FEES and PRIZES: All fees must be paid with the entry application. Ratios for the prize money pay out are: Team, Doubles, Singles - at least 1 in 5 entries and All Events Handicap/Scratch - at least 1 in 5 entries. Awards will be given to winners in each event from the expense fee at the Open Association Annual Meeting/Awards Program.
4. MULTIPLE PARTICIPATION: Bowlers can bowl twice in each event and cash as follows:
A. Second team cannot have more than two bowlers alike
B. Second doubles partner is not the same
C. You can cash only once in Singles
D. Your first score in each event counts toward All Events.
5. AVERAGES and HANDICAP: Averages will be accepted in the following order:

A: Highest 2022-2023 Yearbook average (adults and youth that moved up)
B: Highest average as of 31 Dec 2023
C: Highest 2022 Summer League Average
D: Averages above will be for 21 games - if bowler does not have the above, she may use her 12game current league average as of January 12, 2024. All others will bowl scratch.
Handicap is figured at $90 \%$ of the difference between bowler's average and 220 .
6. Rule 319 a 2 - Ten pin rule does not apply

Rule 319a3 - Each bowler is responsible for verifying their average.
Rule 319a4 - Corrections to bowler's average can be made up to the end of the first series bowled. Rule 319 d - Entrants who have qualified for $\$ 300$ or more in cash and/or merchandise in a single event, the combined prize money won in excess of $\$ 500$ in a tournament, and/or the combined prize money won in excess of $\$ 1000$ in all tournaments competed in within 12 months shall report their winnings to the tournament officials.
Rule 319 e - Reporting scores for the previous 12-month period - does not apply
7. TARDY BOWLERS: Bowlers arriving after the game has started will be allowed to bowl with the score of zero (0) in frames missed. (USBC Rule 322a)
8. PROTEST: Any protest affecting eligibility or general playing rules must be filed within the time limits in accordance with USBC Rule 329.
9. OFFICIAL SCORES: The tournament recap sheet will be the official score sheet. Scores will be verified from the automatic score printouts.
10. Any rule not addressed in these rules will be covered by the USBC Rules Book.
11. Tournament Directors have the final authority.
12. If 6 or more teams bowl, the Championship Team members will be reimbursed for a paid Team entry into the Georgia State USBC Women's Championship Tournament for the current season.
